RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to each part of your request is below.

In the request you asked:

I am collating details of the amount of public sector workers in Nottinghamshire currently off work because of coronavirus.

Please could you supply me with the most up to date figures you have for:

- The number of members of your workforce who currently have confirmed coronavirus
  - As of 7<sup>th</sup> April 2020, 0 confirmed cases and we have had zero staff admitted to hospital.
- The number of members of your workforce who have had confirmed coronavirus but have recovered
  - As of 7<sup>th</sup> April 2020, 0 confirmed cases – as above
- The number of members of your workforce who are currently self-isolating with symptoms of coronavirus, or as a result of member(s) of their family having symptoms
  - As of 7<sup>th</sup> April 2020, we currently have 18 staff across the organisation who have reported they are self-isolating. However, all of our workforce has the ability to work from home and most are now working from home. If members of staff are feeling well enough to work whilst self-isolating all staff have the ability to do so.
- The number of members of your workforce who have completed a period of self-isolation after experiencing symptoms of coronavirus, or as a result of member(s) of their family having symptoms
  - We have collated information based on actual sickness absence not on periods of self-isolation as our workforce has the ability to work from home whilst in self-isolation if well enough to do so. All CCG staff are required to adhere to current Government recommendations in relation to COVID 19 symptoms and self isolation.

If you could also please provide me with a figure for your usual total workforce it would help to put the figures into perspective.

- 509 Headcount at the 31<sup>st</sup> March 2020.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire CCG have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office, who will consider whether the organisation has complied with its obligations under the Act, and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire Clinical Commissioning Group formerly known as NHS Mansfield and Ashfield Clinical Commissioning Group, NHS Newark and Sherwood Clinical Commissioning Group, NHS Rushcliffe Clinical Commissioning

Group, NHS Nottingham West Clinical Commissioning Group, NHS Nottingham City Clinical Commissioning Group and Nottingham North and East Clinical Commissioning Group.
