RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do not hold the information that you have requested.

In the request you asked:

The PPE protocol issued yesterday is still different from WHO guidance relating to COVID-19 patients in primary care. The WHO guidance stipulates long sleeved gowns and even in the evidence section on the GOV.uk website it states that the Cochrane Systemic review 2019 of PPE concluded

"that gowns may protect better against contamination than Aprons "

Could you kindly provide GPS, Practice and Community HCW with long sleeved gowns please?

I am sorry but I am not happy to take my chance with wearing an Apron seeing patients with respiratory symptoms of COVID-19 especially in a home setting when the viral load is high and risk of significant illness and death is high.

Also could you provide me with the number of COVID-19 cases and deaths of Health care workers, including GPs in the UK please.

The CCG does not hold the information requested regarding COVID-19 cases and deaths of health workers, including GPs in the United Kingdom. Please note that only the highlighted section above has been processed as Freedom of Information request. Your query regarding PPE is being raised by the Primary Care Cell within the CCG's Incident Response Centre and the Quality Scrutiny Panel.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Clinical Commissioning Group have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office, who will consider whether the organisation has complied with its obligations under the Act, and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire Clinical Commissioning Group formerly known as NHS Mansfield and Ashfield Clinical Commissioning Group, NHS Newark and Sherwood Clinical Commissioning Group, NHS Rushcliffe Clinical Commissioning Group, NHS Nottingham West Clinical Commissioning Group, NHS Nottingham City Clinical Commissioning Group and Nottingham North and East Clinical Commissioning Group.
