RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we partially hold the information that you have requested. A response to each part of your request is below.

In the request you asked:

1) How much have you been allocated by the £1.3bn fund to support faster patient discharges from hospital during the covid-19 pandemic?

The CCG has not been allocated a proportion of the £1.3bn fund. Instead the CCG is required by regulators to submit a claim for costs associated with the faster patient discharges from hospital that are incurred by the CCG and its 2 Local Authorities.

2) How much have you spent of your allocation from the £1.3bn covid-19 discharge fund?

See response to Q1. As at the end of June 2020 associated costs were £5.323m.

3) How much has your local authority contributed towards the £1.3bn covid-19 discharge fund?

The CCG does not hold this information; please contact Nottingham City Council and Nottinghamshire County Council.

3) How many care homes did you provide oxygen to as a result of covid-19 outbreaks between:

a) March 1st to April 15th

b) April 15th to June 16th

The East Midlands HOS supplier is contracted to provide Home Oxygen Services on a 'named' patient basis only and therefore the East Midlands HOS Contractor **would not** supply oxygen equipment as a 'generic' supply to a Care Home. Declaring the number of patients in each Care Home in receipt of Home Oxygen specifically for COVID-19 may enable those patients to be identified and therefore under the data protection regulations this information cannot be shared.

3) How many covid-19 outbreaks have there been in care homes in your area from March 1, 2020 to date?
