RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to each part of your request is below.

In the request you asked:

Please provide a copy of, or link to, your clinical threshold policy for cataract surgery and state whether this has changed in the past 4 years. If it has changed, please provide a copy of, or link to, the former policy and date of change.

For each of the four financial years;

- 1. 2016-17 b) 2017-18 c) 2018-19 d) 2019-20, please provide for each year:
- 1. The CCG registered population

2. The number of Individual Funding Requests (IFRs) and/or prior approval (PA) requests that the CCG received for cataract surgery

3. The number of Individual Funding Requests (IFRs) and/or prior approval (PA) requests that the CCG approved for cataract surgery

4. The CCG's total activity for cataract surgery (i.e. the total number of procedures carried out)

5. The average waiting time in days for cataract surgery from first referral

And for each month, beginning January 2019, to present:

6. The CCG's total activity for cataract surgery (i.e. the total number of procedures carried out)

7. The average waiting time in calendar days for cataract surgery for the procedures completed in that month

Please supply this information in an Excel Spreadsheet. I have attached a template to this request.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Clinical Commissioning Group have an internal review procedure through which you can raise any concerns you might have. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by
