 How many people in your CCG have been awarded a Continuing Healthcare budget and how many of these have taken up a PHB?

- For the period 01.04.19 to 31.03.20 the CCGs had 2487 people made eligible for Continuing Healthcare across Nottinghamshire and of these, 171 patients on a Direct Payment, 713 Notional Budgets and 7 Third Party PHB.

- What is the total annual spend on PHBs for your CCG, and how that spend breaks down by Direct Payment, 3rd party managed and notional budgets?
 - For 2019/20, the budgeted spend for Direct Payments was £9,222,455.53.

- For 2019/20, the budgeted spend for Notional Budgets was £8,008,800.50.
- For 2019/20, the budgeted spend for Third Party was £727,778.67.
- In the report published by NHS England (https://www.england.nhs.uk/publication/personal-health-budgets-mandatorydata-collection-guidance-and-data/) you have declared 693 PHBs in the "other" category, can you please provide a breakdown of what types of PHBs these are? E.g. Wheelchair PHBs, end of life etc?

 - Looked after Children
 - Survivors of Historical Sexual Abuse
- What software, if any, is used to manage PHBs in your CCG?

- What is the total annual cost for this software and what licensing model is used, e.g. X% of budget/per user/fixed cost

- When is the contract for the PHB software up for renewal?
