RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to each part of your request is below.

Please note, as of 1st April 2020 the following Clinical Commissioning Groups (CCGs), NHS Mansfield & Ashfield CCG, NHS Newark & Sherwood CCG, NHS Nottingham City CCG, NHS Nottingham North & East CCG, NHS Nottingham West CCG and NHS Rushcliffe CCG, merged to become NHS Nottingham and Nottinghamshire CCG. In the request you asked:

- Details of the approach/treatment pathway for COSMHAD treatment that you commission or provide – particularly whether you commission or provide treatment specifically for COSMHAD

Nottingham and Nottinghamshire CCG commissions mental health treatment services, predominantly from Nottinghamshire Healthcare NHS Trust. The local councils (Nottingham City Council and Nottinghamshire County Council) are responsible for commissioning substance misuse treatment services (Nottingham Recovery Network in the City, and Change, Grow, Live in the County). Although the CCG doesn't commission a standalone service for patients with a dual diagnosis, these patients are not excluded from mental health services and where possible, mainstream services are encouraged to work together to meet co-occurring needs. Local challenges have been identified and as a system we are working together to inform a revised pathway in line with NICE guidance that will be implemented as part of wider community mental health transformation plans.

- Details of any other COSMHAD services you are aware of operating within your area

There is no single COSMHAD/ dual diagnosis lead however the Systems Pathway Group is chaired by a Public Health Consultant who works for Nottingham City Council. Please contact Nottingham City Council for further details.

Generally, the ICO cannot make a decision unless you have exhausted
