RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we partially hold the information that you have requested. A response to each part of your request is below.

Please note, as of 1 April 2020 the following Clinical Commissioning Groups (CCGs), NHS Mansfield & Ashfield CCG, NHS Newark & Sherwood CCG, NHS Nottingham City CCG, NHS Nottingham North & East CCG, NHS Nottingham West CCG and NHS Rushcliffe CCG, merged to become NHS Nottingham and Nottinghamshire CCG. In the request you asked:

1. Have your CCG implemented COVID OXIMETRY @ HOME?

Yes, the CCG has implemented Covid Oximetry at home.

2. Which technology supplier have you used to implement COVID OXIMETRY @ HOME and when does the contract expire?

We do not hold this information as the CCG has not commissioned a technology supplier to support the implementation of Covid Oximetry at home.

3. Do you plan to use technology to support the implementation of COVID OXIMETRY @ HOME?

The CCG has no plans to commission any additional technology to support the roll out of Covid Oximetry at home.

4. Who is responsible for implementing the project COVID OXIMETRY @ HOME?

Each of the Integrated Care Partnerships (ICPs) has a Locality Director who is overseeing local implementation, supported by a CCG Project Manager.

Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire Clinical Commissioning Group formerly known as NHS Mansfield and Ashfield Clinical Commissioning Group, NHS Newark and Sherwood Clinical Commissioning Group, NHS Rushcliffe Clinical Commissioning Group, NHS Nottingham West Clinical Commissioning Group, NHS Nottingham City Clinical Commissioning Group and Nottingham North and East Clinical Commissioning Group.
