RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we partially hold the information that you have requested. A response to each part of your request is below.

Please note, as of 1 April 2020 the following Clinical Commissioning Groups (CCGs), NHS Mansfield & Ashfield CCG, NHS Newark & Sherwood CCG, NHS Nottingham City CCG, NHS Nottingham North & East CCG, NHS Nottingham West CCG and NHS Rushcliffe CCG, merged to become NHS Nottingham and Nottinghamshire CCG. In the request you asked:

- Please supply me with your most up to date wound care formulary (please indicate if you do not work from a formulary)?
 The wound care formulary can be found on the Nottinghamshire Area Prescribing Committee website www.nottsapc.nhs.uk
- 2. Who has operational responsibility for the formulary including the addition or deletion of products? Wound care formulary group?
 - Nottingham CityCare tissue viability service and Nottinghamshire Healthcare NHS Foundation Trust tissue viability team have operational responsibility for the formulary.
- 3. Please provide information on how compliance with your formulary is enforced?
 - The CCG does not hold this information.
- 4. Please provide information on who is responsible for the cost of wound care in your setting is it CCG or Acute?

 The CCG is responsible for the cost of wound care.
- Please provide information if the wound care products are on prescription FP10 or do you purchase through NHSSC?
 This is a mixed approach depending on locality.
- 6. Please provide a list of the wound care products that you are planning to keep on prescription FP10?

 The CCG does not hold this information.
- 7. Please provide any information that you have relating to the average monthly usage of each product in the formulary?

- 8. Please provide information on the number of wound care products used and there spend that are not currently on the formulary in the last 12 months?

The wound care formulary is reviewed every 2 years with interim updates as required. The last review of the wound care formulary was in 2019.

Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire Clinical Commissioning Group formerly known as NHS Mansfield and Ashfield Clinical Commissioning Group, NHS Newark and Sherwood Clinical Commissioning Group, NHS Rushcliffe Clinical Commissioning Group, NHS Nottingham West Clinical Commissioning Group, NHS Nottingham City Clinical Commissioning Group and Nottingham North and East Clinical Commissioning Group.
