RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do not hold the information that you have requested.

Please note, as of 1 April 2020 the following Clinical Commissioning Groups (CCGs), NHS Mansfield & Ashfield CCG, NHS Newark & Sherwood CCG, NHS Nottingham City CCG, NHS Nottingham North & East CCG, NHS Nottingham West CCG and NHS Rushcliffe CCG, merged to become NHS Nottingham and Nottinghamshire CCG. In the request you asked:

I note that your Trans Equality Policy states the following:

- Research supports the belief that transsexuality is a condition developed by the foetus in the womb. At twelve weeks, if the foetus is to be male, the mother's body produces a burst of the male hormone, testosterone, which masculinises the internal and external genitalia. However, it is not until four weeks later that a second hormonal trigger masculinises the brain of the foetus.
- Male and female brains differ significantly in the construction of the hypothalamus, which is responsible for the production of male/female hormones. Should one of these two hormonal triggers fail to occur, a baby will be born with the physical attributes of one gender, and the brain functions of the opposite gender.

Given that you are a publicly funded body with a duty to operate on the basis of scientific evidence, I was wondering whether you might be kind enough to cite the peer-reviewed research on which these statements are based? I would also be grateful if you could comment on whether any clinical/scientifically trained staff have been involved in drafting this document.

We do not hold this information as the policy referenced is a legacy policy of a predecessor organisation that has now been disestablished (e.g. the policy is no longer active).

Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire Clinical Commissioning Group formerly known as NHS Mansfield and Ashfield Clinical Commissioning Group, NHS Newark and Sherwood Clinical Commissioning Group, NHS Rushcliffe Clinical Commissioning

Group, NHS Nottingham West Clinical Commissioning Group, NHS Nottingham City Clinical Commissioning Group and Nottingham North and East Clinical Commissioning Group.
