RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to each part of your request is below.

Please note, as of 1 April 2020 the following Clinical Commissioning Groups (CCGs), NHS Mansfield & Ashfield CCG, NHS Newark & Sherwood CCG, NHS Nottingham City CCG, NHS Nottingham North & East CCG, NHS Nottingham West CCG and NHS Rushcliffe CCG, merged to become NHS Nottingham and Nottinghamshire CCG. ## In the request you asked:

- 1. Which department or departments are responsible for overseeing legal affairs when your CCG is a party to a legal Hearing e.g. Legal Services, HR? Legal hearings such as those brought against or for the CCG (high court, coroners court, criminal proceedings), or more internal matters eg. Employment Tribunal
  - i. Please can you provide the name and contact details of the people overseeing this department(s)?
  - ii. Within this department(s), please, can you provide the details of staff who are responsible for day-to-day managing of the following legal areas; Commercial Litigation, Crime, Crime-Fraud, Employment, Intellectual Property, Litigation General.
- 2. Which department or departments are responsible for managing/supporting staff who are giving evidence at a legal hearing i.e. providing time off to attend court or providing support with training.
  - i. Please can you provide the name and contact details of the people overseeing this department(s)?

The Corporate Governance Team within NHS Nottingham and Nottinghamshire CCG has overall responsibility, and oversight, of legal affairs and co-ordinates with relevant department(s)/staff dependent on the nature of the legal advice (e.g. Estates, HR, Procurement). The senior manager for this team is Lucy Branson, Associate Director of Governance, and is contactable on <a href="mailto:lucy.branson@nhs.net">lucy.branson@nhs.net</a>.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Clinical Commissioning Group have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office, who will consider whether the organisation has complied with its obligations under the Act, and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire Clinical Commissioning Group formerly known as NHS Mansfield and Ashfield Clinical Commissioning Group, NHS Newark and Sherwood Clinical Commissioning Group, NHS Rushcliffe Clinical Commissioning Group, NHS Nottingham West Clinical Commissioning Group, NHS Nottingham City Clinical Commissioning Group and
