RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to each part of your request is below.

Please note, as of 1 April 2020 the following Clinical Commissioning Groups (CCGs), NHS Mansfield & Ashfield CCG, NHS Newark & Sherwood CCG, NHS Nottingham City CCG, NHS Nottingham North & East CCG, NHS Nottingham West CCG and NHS Rushcliffe CCG, merged to become NHS Nottingham and Nottinghamshire CCG. In the request you asked:

I am currently doing some work around pulmonary rehab and benchmarking.

Is there any information you might be able to assist with around workforce/activity/finances etc?

I am specifically looking for:

- 19/20 and 20/21 activity for the pulmonary rehabilitation service in the community
- number and types of people employed for the delivery of the service in the community
- the name of the provider
- specification
- any finance/costings you can provide

Please see attached documents in response to the above request. The service specifications and the Activity KPI reporting for 2019/20 and 2020/21 are attached. These services are provided by Nottingham CityCare Partnership (in Nottingham City) and Nottinghamshire Healthcare NHS Trust (in Nottinghamshire South and Mid Nottinghamshire). Pulmonary rehab services are commissioned as part of integrated out of hospital community services contracts and therefore specific finance, costings and staffing information are not held for these services.

During the initial response to the COVID-19 pandemic there was disruption to secondary care referrals and discharges.

Please note, as of 1 April 2020 the following Clinical Commissioning Groups (CCGs), NHS Mansfield & Ashfield CCG, NHS Newark & Sherwood CCG, NHS Nottingham City CCG, NHS Nottingham North & East CCG, NHS Nottingham West CCG and NHS Rushcliffe CCG, merged to become NHS Nottingham and Nottinghamshire CCG however the CCG still uses the geographical areas of the former CCGs to monitor activity for this service.

Please note that where '≤5' has been used this is to represent 5 or less patients and is used to ensure patient confidentiality.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Clinical Commissioning Group have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office, who will consider whether the organisation has complied with its obligations under the Act, and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire Clinical Commissioning Group formerly known as NHS Mansfield and Ashfield Clinical Commissioning Group, NHS Newark and Sherwood Clinical Commissioning Group, NHS Rushcliffe Clinical Commissioning Group, NHS Nottingham West Clinical Commissioning Group, NHS Nottingham City Clinical Commissioning Group and Nottingham North and East Clinical Commissioning Group.
