- 3. The top 10 longest waits for treatment in CAMHS, including how long they've waited and reason for referral from 1st April 2020 31st March 2021.

The CCG does hold this information however it cannot be disclosed due to being a small number of patients. If disclosed this could potentially identify the individuals involved, especially if combined with other data, and this would constitute a

breach of the Data Protection Act 2018. Therefore, this information is exempt from disclosure under section 40(2) of the Freedom of Information Act 2000 on the grounds that it is personal information.

\*Examples of reasons for referrals (not exclusive): Anxiety, attention behaviour pathway, autism, depression, eating disorders, obsessive compulsive disorder and body dysmorphic disorder, PTSD, psychosis, self harm, disorders inclusive of tourettes.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Clinical Commissioning Group have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office, who will consider whether the organisation has complied with its obligations under the Act, and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire Clinical Commissioning Group formerly known as NHS Mansfield and Ashfield Clinical Commissioning Group, NHS Newark and Sherwood Clinical Commissioning Group, NHS Rushcliffe Clinical Commissioning Group, NHS Nottingham West Clinical Commissioning Group, NHS Nottingham West Clinical Commissioning Group.
