RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do not hold the information that you have requested.

In the request you asked:

I'd like to know how many people were living with, living beyond and dying from each of the following diseases in your area over the following years:

Kidney cancer

Testicular cancer

Ulcerative colitis

Thyroid disease

Pregnancy induced hypertension (including preeclampsia)

Hypercholesterolemia

Please include the number of people affected as a total number, but also as a rate (per 100,000 people) and as a proportion of the population covered by your ccg.

For the years: 2015, 2016, 2017, 2018, 2019 and 2020

Please also include the geographical extent of the area covered by your cc group.

NHS Nottingham and Nottinghamshire CCG do not hold the requested information in the level of detail required to respond to your request. Please see attached spread sheet for kidney cancer incidence and mortality data that is publically available. The below website links offer insight into certain cancer metrics.

If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office, who will consider whether the organisation has complied with its obligations under the Act, and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire Clinical Commissioning Group.
