RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we partially hold the information that you have requested. A response to each part of your request is below.

In the request you asked:

How much has the CCG spent on ASD diagnosis and assessment each year for the last 3 years, and how much will be invested next year.

Please see below for the CCG spend on adult Autism Spectrum Disorders (ASD) diagnosis and assessment each year.

**2018/19:** £347,000

**2019/20:** £372,000

**2020/21:** £352,000

**2021/22:** £2,361,760 (*this is for Neurodevelopmental Specialist Service which is Autism and ADHD assessment and treatment*)

**2022/23:** £2,361,760 (*confirmed contractual investment for the Neurodevelopmental Specialist Service - Autism and ADHD assessment and treatment*)

Please note that this year's spend and next year's investment is not exclusively for Autism but includes ADHD as well as the CCG commission both through one service.

NHS Nottingham and Nottinghamshire CCG do not hold this information for children's Autism Spectrum Disorders (ASD) diagnosis and assessment as assessments take place within Nottingham University Hospitals and Sherwood Forest Hospitals Community Paediatrics and Community Child and Adolescent Mental Health Services (CAMHS). You may wish to contact Nottingham University Hospitals NHS Trust, Sherwood Forest Hospitals NHS Foundation Trust and Nottinghamshire Healthcare NHS Foundation Trust to request this information. If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Clinical Commissioning Group have an internal review procedure through which you can raise any concerns you might have.
