RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to each part of your request is below.

In the request you asked:

Via the Freedom of Information Act, I would like to request a pdf copy of the rheumatology high cost drugs pathway for CCGs under your jurisdiction for the following conditions:

- rheumatoid arthritis
- psoriatic arthritis, and
- ankylosing spondylitis

The requested pathways are publicly available via the Nottinghamshire Area Prescribing Committee website under clinical guidelines and high cost pathways - <https://www.nottsapc.nhs.uk/guidelinesformularies/>

Please note that these documents are in the process of being updated and revised versions are in the process of being finalised. Updated versions of the pathways mentioned will be available on the Nottinghamshire Area Prescribing Committee website in approximately two weeks.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Clinical Commissioning Group have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office, who will consider whether the organisation has complied with its obligations under the Act, and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire Clinical Commissioning Group.
