In the request you asked:

The CCG has an internally hosted Umbraco site that is managed by our IT department Nottinghamshire Health Informatics Service (NHIS).

3. How long have you been using this intranet solution?

8 years

4. When is your intranet contract up for renewal?

N/A

5. What is your annual intranet budget?

The CCG does not hold this information as it forms part of a wider contract with NHIS which includes developer days that can be used for any project (including the intranet).

6. What is your procurement process? Please can you include any portals used to list tenders and/or any suppliers/consultants used to procure.

Nottingham and Nottinghamshire CCG source procurement support from NHS Arden & GEM CSU and their procurement portal EU Supply. There are several procurement routes available to us is dependent upon both the subject matter and the value. We use the Find a Tender Portal along with the Contracts Finder Portal. Where available though we endeavor to use Public Sector

Framework Agreements which will include but not limited to Crown Commercial Services, NHS Shared Business Services, HealthTrust Europe, London Procurement Partnership, ESPO and the G-Cloud 12 Digital Marketplace.

7. Do you share intranet/IT services with other organisations, if so who? Which team and/or individual(s) are responsible for managing your intranet internally?

GP Practices within Nottingham and Nottinghamshire have access to the CCG intranet site and the content is managed by the Communication and Engagement and Corporate Assurance Team.

8. Are you using the Office 365 suite? If so, which applications from the suite are in use?

The CCG uses Office 365 for the NHS and have access to all the applications.

9. Which team and/or individual(s) are responsible for your intranet's procurement within the organisation?

The Communication and Engagement Team in collaboration with procurement team are responsible for the procurement of the CCG intranet.

10. Is your Active Directory hosted on-premise, or in the cloud?

The CCG has an on-premise Active Directory.

11. Could you provide us with a link to your Digital Workplace Strategy?

The CCG does not have a Digital Workplace Strategy.
