**RE: Freedom of Information Request**

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we partially hold the information that you have requested. A response to each part of your request is below.

Please note that both NHS Nottingham and Nottinghamshire, and Bassetlaw Clinical Commissioning Groups ceased operation on 30 June 2022. They have been superseded by NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) which began operation on 1 July 2022.

In the request you asked:

I am trying to get data to compare the adult populations of two different areas.

a) the first is the adult population of an area consisting of

- Bassetlaw in North Nottinghamshire including Worksop, this being part way between Worksop and Mansfield,
- and South Yorkshire including greater Sheffield and greater Doncaster,
- and also East Lincolnshire including greater Lincoln,
- as well as North Derbyshire part way between Worksop and the city of Derby or part way between Worksop and Chesterfield.

b) the second is the adult population of an area in and around Mansfield

- bounded by this area to part way to Worksop,
- and part way to Newark,
- and part half way to Nottingham,
- and part way to Derby,
- as well as part way to Chesterfield.

- Would it be possible to include maps of both these areas (Bassetlaw and Mansfield), with your copyright permission to copy and paste these into longer documents?  
Nottingham and Nottinghamshire ICB does not hold information in relation to the geographical areas of South Yorkshire including greater Sheffield and greater Doncaster, East Lincolnshire including greater Lincoln and North Derbyshire part way between Worksop and the city of Derby or part way between Worksop and Chesterfield. It might be that the ICB with commissioning responsibility for these areas is able to provide the information you require. For ease of reference their contact details are below:

Charlotte Evans is an Administrator within the Nottingham and Nottinghamshire Integrated Care Board.
- A list of people and their contact details who, in your consultation, were in favour of keeping mental health services within Bassetlaw.

The ICB does not hold this information. Any names and email addresses given to the ICB as part of a consultation exercise would be regarded as personal information/ third party personal

information and would be exempt from disclosure under section 40(2) of the Freedom of Information Act 2000.

As defined by the Data Protection Act, personal data constitutes as:

“Personal data” means any information relating to an identified or identifiable living individual.

“Identifiable living individual” means a living individual who can be identified, directly or indirectly, in particular by reference to -

(a) an identifier such as a name, an identification number, location data or an online identifier, or

(b) one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of the individual

Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
