RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we partially hold the information that you have requested. A response to each part of your request is below.

Please note that both NHS Nottingham and Nottinghamshire, and Bassetlaw Clinical Commissioning Groups ceased operation on 30 June 2022. They have been superseded by NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) which began operation on 1 July 2022.

In the request you asked:

 All current IAPT contracts are due to expire on 31/03/2023
- 4. Is there an optional contract extension in place for this/these IAPT service(s)? If so, for how long?
 - No option in place to extend the current contracts
- Does the ICB have current plans to go out to tender for a new IAPT service(s) and if so, when?
 Yes. The closing date for bids for the service starting 1 April 2023 was 19 September 2022 at 2pm.
- 6. What is the current annual value of the ICBs current IAPT Service(s)?

The current value is variable as the contracts are a mixture both block and Any Qualified Provider (AQP), payment is based on activity on an AQP contract however the total value of the contract starting 1 April 2023 is £97,070,000.00.
