## **RE: Freedom of Information Request**

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we partially hold the information that you have requested. A response to each part of your request is below.

In the request you asked:

- The number of people in your ICB/ICP area who have been diagnosed with Epidermolysis Bullosa during the past five years.

- 2. The number of people with Epidermolysis Bullosa referred to one of the UK's specialist EB treatment centres in the past five years.

Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
