RE: Freedom of Information Request

With reference to your request for further information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to each part of your request is below.

In the request for further information you asked for:

The monthly ARRS breakdowns that are available up until the most recent available month (November 2022).

It is our understanding now having received responses and files from other ICB's that although the full end of year data is clearly not fully available yet, there is available a current monthly breakdown of expenditure per PCN within the ICB until the present month.

Please see attached document NN-ICB 22 122b which outlines reported spend for ARRS by Primary Care Network (PCN), by month for the period from April to November 2022. This relates to the PCN's within Nottingham and Nottinghamshire (excluding Bassetlaw).

The Bassetlaw PCNs joined the ICB in July, and we don't hold their data prior to them joining. This information has been requested and will be provided in the New Year once obtained.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
