RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we partially hold the information that you have requested. A response to each part of your request is below.

Please note that both NHS Nottingham and Nottinghamshire, and Bassetlaw Clinical Commissioning Groups ceased operation on 30 June 2022. They have been superseded by NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) which began operation on 1 July 2022.

In the request you asked:

I would like to be informed of all the contracts between your Integrated Care Board and all non-NHS providers for health, mental health, children's services, and social care services in your ICS area, including the start and end dates of the contracts.

All contracts from the legacy organisations of NHS Nottingham and Nottingham CCG and NHS Bassetlaw CCG were transferred to NHS Nottingham and Nottinghamshire ICB (ICB) on 1 July 2022. An extensive programme of work is currently underway to review the ICB's contracts register to ensure it is accurate and reflective of the newly established statutory body.

We have published the ICB's contract register, as it stands on the 18 August 2022 at the following link on the website <u>https://notts.icb.nhs.uk/about-us/what-we-spend-and-how-we-spend-it/procurement/</u>. However, please note that work in relation to the register is ongoing.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
