RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we partially hold the information that you have requested. A response to each part of your request is below.

Please note that both NHS Nottingham and Nottinghamshire, and Bassetlaw Clinical Commissioning Groups ceased operation on 30 June 2022. They have been superseded by NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) which began operation on 1 July 2022.

In the request you asked:

I would be grateful if you would provide the relevant information in respect of the enquiries below under the Freedom of Information Act in view of a proposed acquisition of the pharmacy named below:

Manns Pharmacy ("the Pharmacy") - Manns Pharmacy Limited 852A Woodborough Road Nottingham Nottinghamshire NG3 5QQ United Kingdom

Please provide the following information and any supporting documentation in relation to the pharmacy listed above:

- Details of any applications submitted within the last 3 years by any persons to open any GP practice in any premises within postcodes NG2, NG3, NG4 and NG5 (Postcode Area) NB MAIN POSTCODE BEING NG3; 0
- 2. Details of any applications submitted within the last 3 years by any persons to relocate any GP practice from any premises currently situated within the Postcode Area; 0
- 3. Details of any applications submitted within the last 3 years by any persons to merge any GP practice in relation to any GP practice situated within the Postcode Area;

The Jubilee Practice and Park House Medical Centre (61 Burton Rd, Carlton, Nottingham NG4 3DQ) applied to undertake a full contractual merger in December 2019, which was approved by the Primary Care Commissioning Committee of the legacy organisation of the CCG. The merger commenced in June 2020.

4. Details of any applications submitted within the last 3 years by any person to open a pharmacy in premises within the Postcode Area;

We don't hold this information, NHS England commission pharmacy services

5. Details of any applications submitted within the last 3 years by any person to relocate any pharmacy to premises within the Postcode Area;

If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
