RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to your request is below.

Please note that both NHS Nottingham and Nottinghamshire, and Bassetlaw Clinical Commissioning Groups ceased operation on 30 June 2022. They have been superseded by NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) which began operation on 1 July 2022.

In the request you asked:

Please could you advise whether the Nottingham & Nottinghamshire ICB will be publishing a primary care medicines formulary for use by prescribers, or will the former CCGs be keeping their own formularies and guidelines.

Please also provide information and links to the current formulary/formularies for relevant areas if individual area formularies are going to be continued.

NHS Nottingham and Nottinghamshire ICB will be following the <u>Nottinghamshire Joint Formulary</u>, with the exception of Bassetlaw. Bassetlaw follow some areas of the Nottinghamshire formulary e.g. mental health, but due to the population accessing acute services in Doncaster and Sheffield, then the <u>Doncaster</u> and Bassetlaw Medicines Formulary will still be followed.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
