**Dear Requestor** 

**RE: Freedom of Information Request** 

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we partially hold the information that you have requested. A response to your request is below.

Please note that both NHS Nottingham and Nottinghamshire, and Bassetlaw Clinical Commissioning Groups ceased operation on 30 June 2022. They have been superseded by NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) which began operation on 1 July 2022.

In the request you asked:

As the Palliative and End of Life Care Statutory Guidance for Integrated Care Boards (ICBs) (20 July 2022) has been published, we'd like to hear from ICBs on whether they have actioned the Palliative and End of Life Care self-assessment, to identify progress and gaps against the six Ambitions commitments (involving people with lived experience), please.

Is it possible to receive a copy of your self-assessment, if this is public, or be put into contact with someone who is able to assist with this.

Nottingham and Nottinghamshire Clinical Commissioning Group completed the Palliative and End of Life Care self-assessment on the 4 December 2020 (attached as document NN-ICB/22/41b). This informed the Nottingham and Nottinghamshire Integrated Care System's End of Life Strategy (attached as document NN-ICB/22/41c).

As Bassetlaw Clinical Commissioning Group was not part of the Nottingham and Nottinghamshire Integrated Care System at that time it was not included. However, Nottingham and Nottinghamshire Integrated Care Board (which includes the locality of Bassetlaw) is intending on completing the self-assessment toolkit again in the future to identify progress. The date for completion has yet to be agreed.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and
