RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do not hold the information that you have requested. A response to your request is below.

Please note that both NHS Nottingham and Nottinghamshire, and Bassetlaw Clinical Commissioning Groups ceased operation on 30 June 2022. They have been superseded by NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) which began operation on 1 July 2022.

In the request you asked:

Please could you tell me whether you implement a 'same-sex' personal care policy for your social care service users? Or if you have moved to a 'gender based' policy?

Does this policy apply to social care users who receive CHC funding provided by you, as well as those who receive council funded social care?

Please provide proof of your policy.

Nottingham and Nottinghamshire Integrated Care Board does not hold this information as we are a commissioning organisation not a provider of social care services. It might be that the local authorities can provide the information you require, for ease of reference their contact details are below:

Do you instruct all care agencies in the area to comply with your policy or are each able to implement their own policy?

Whilst we don't have a specific policy (as per our answer above) we support individuals to have a choice in where they receive care and how that care is delivered.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations

under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
