RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to each part of your request is below.

In the request you asked for the following information from the CCG Fully funded Learning Disability & Autism Team:

- Name, phone number and email address for the lead commissioner for Learning Disability & or Autism
- Name, phone number and email address for the Transforming care lead for the CCG

Please note that both NHS Nottingham and Nottinghamshire, and Bassetlaw Clinical Commissioning Groups ceased operation on 30 June 2022. They have been superseded by NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) which began operation on 1 July 2022.

Please also note that there is not a 'CCG Fully Funded Learning Disability & Autism Team' instead this response is from the Nursing & Quality Directorate.

• Lead commissioner for Learning Disability & or Autism

As an ICB we work in partnership with our local authority colleagues to agree respective responsibilities for commissioning which considers the needs of the individual. As a statutory NHS body, the ICB is responsible for the planning and commissioning of health care services for their local area.

The Nottingham and Nottinghamshire ICB are part of system collaboration working with Local Authorities, Provider Collaboratives, and NHS England Specialised Commissioning. Responsibility for learning disabilities and/or autism commissioning is a collaboration across our partnership.

NHS-funded Nursing Care is the funding provided by the NHS to care homes with nursing, to support the provision of nursing care by a registered nurse for those assessed as eligible for NHS-funded Nursing Care.

• Transforming care lead for the CCG

Building the Right Support was published in 2015 by NHS England, the Local Government Association, and the Association of Directors of Adult Social Services as part of the national 'Transforming Care Programme'.

'Transforming Care' is about improving health and care services so that more people can live in the community, with the right support, and close to home.

In Nottingham and Nottinghamshire, the term 'transforming care' is the umbrella term of the programme of work across the system to ensure people with a learning disability and/or autism have the same opportunities as anyone else, to live satisfying and valued lives, and to be treated with dignity and respect. The ICB has a Learning Disability and Autism Programme Team in addition to a Head of Quality for Learning Disabilities and Autism. Both are supported by a team comprising of case managers, practitioners, and project leads. Both the work teams work together to ensure they review and plan service provision for adults, children and young people with a learning disability and/or autism.

The Senior Responsible Officer (SRO) for the transforming care programme is the ICB and ICS Chief Nurse supported by the Nottinghamshire County Council Corporate Director (Adult Social Care and Health) and the Medical Director for Nottinghamshire Healthcare NHS Trust. If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
