RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do not hold the information that you have requested. A response to your request is below.

Please note that both NHS Nottingham and Nottinghamshire, and Bassetlaw Clinical Commissioning Groups ceased operation on 30 June 2022. They have been superseded by NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) which began operation on 1 July 2022.

In the request you asked:

I am trying to find out how much it costs to transport a dialysis patient to Nottingham City dialysis unit from their home 25 miles away two journeys a day three days a week.

Nottingham and Nottinghamshire ICB does not hold information relating to the cost of an individual journey as patient transport is commissioned and paid for under a block contract. It might be possible for our patient transport providers to give a better indication of the cost of each journey, however, as private providers they are not subject to the provisions of the Fol Act 2000. For ease of reference their contact details are provided below:

- ERS Medical Limited provides the Non-Emergency PTS across Nottingham and Nottinghamshire, including Bassetlaw Place Based Partnership. They can be contacted via <u>contact@ersmedical.co.uk</u>.
- Premier Care Direct provides the Renal PTS across South Yorkshire, including Bassetlaw Place Based Partnership, but excluding Nottingham City, Mid-Nottinghamshire and South Nottinghamshire Place Based Partnerships. They can be contacted via pet@premiercaredirect.com

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and
