RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to your request is below.

Please note that both NHS Nottingham and Nottinghamshire, and Bassetlaw Clinical Commissioning Groups ceased operation on 30 June 2022. They have been superseded by NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) which began operation on 1 July 2022.

In the request you asked:

- 1. What digital tools are being used across the ICB to support the management of long-term conditions?
 - The ICB is a commissioning organisation that does not deliver care to patients. The tools detailed below are used by primary and secondary providers within the Integrated Care System.
 - Digital questionnaires from TPP SystmOne for reviews (such Asthma Control Test) as well as the same via tools such as AccuRX and MJOG. We also have Patients Know Best (PKB) which can facilitate a patient held care plan which can be used for health and social care.
- 2. How widely are the tools used across the ICB?

 SystmOne, AccuRx and MJOG are widely used in Primary Care, PKB is still being rolled out and adopted in primary and secondary care.
- 3. How are these tools funded?

 TPP SystmOne is funded via GP IT Futures framework, AccuRx and MJOG are funded via System Development Funding and PKB funded via Health System Led Investment funding.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
