RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to each part of your request is below.

Please note that both NHS Nottingham and Nottinghamshire, and Bassetlaw Clinical Commissioning Groups ceased operation on 30 June 2022. They have been superseded by NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) which began operation on 1 July 2022.

In the request you asked:

I am requesting the following information in respect of:

- Diabetes (SMBG test strips/pen needles)
- Wound Care
- Urology
- Oral contraceptives

For each therapy area:

1. The name(s) and direct contact email address(es) and direct telephone numbers of the person(s) in your Medicines Management team/ICB/Health Board who are responsible for the formulary

Nottingham and Nottinghamshire (excluding Bassetlaw): There is no single individual responsible for the formulary. Queries in relation to the formulary can be directed to the Medicines Management Team via nn.nottsapc@nhs.net.

Bassetlaw Place-Based Partnership Only:

For Bassetlaw Place-Based Partnership Only:

Diabetes (SMBG test strips/pen needles) – will be reviewed by Bassetlaw GP Prescribing Leads meeting, when due for review.

Wound Care – as for rest of Nottingham & Nottinghamshire

Urology & Oral Contraceptives - this is managed by Doncaster and Bassetlaw Teaching Hospitals NHS Foundation Trust

Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
