RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to each part of your request is below.

In the request you asked:

• Whether any consultancies were employed in order to advise on, manage or implement the process of transitioning from CCG to ICB, e.g. management consultants

Yes, consultancies were employed in order to advise on, manage or implement the process of transitioning from CCG to ICB.

If so, please provide the following information:

• Which consultancies were employed

Badenoch and Clark, NHS Exec Search and Hunters Healthcare

How much they were paid

The total amount paid to the above consultancies £132.5k, of which £28.2k was funded by NHS England so wasn't a cost incurred by NHS Nottingham and Nottinghamshire CCG.

• What services they provided

Recruitment of Chair, Chief Executive Officer, four Executive Director and four Non-Executive Director posts for NHS Nottingham and Nottinghamshire ICB.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
