**RE: Freedom of Information Request**

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we partially hold the information that you have requested. A response to each part of your request is below.

In the request you asked:

**CYP ADHD**

1. Please name the organisation(s) that deliver(s) CYP (children and young people) ADHD assessment / diagnoses in your ICB area
  - Nottingham University Hospitals NHS Trust
  - Sherwood Forest Hospitals NHS Foundation Trust
- a. When did the contract(s) begin and when is the contract(s) due to end  
Acute NHS contracts are reviewed on an annual basis.
- b. What is the annual spend for this service for 2022, and for the last 5 years?  
The cost of the service is within a wider block payment for the acute contracts which includes other services.
- c. How is the service contracted – is it Block, Activity-based, or AQP contracting?  
Block contracts.
- d. If the service is commissioned with other CCGs, ICSs or Trusts, which are these?  
N/A
- e. At what prevalence (% of the child population) have the contracts been commissioned against?  
The service specifications are based on level of need not % of the child population.
2. Does the same organisation as for Question 1 also deliver CYP ADHD prescriptions and post-diagnosis ADHD support in your ICB area? If not, please provide the same information for this organisation.  
Yes. There is also a shared care protocol in place that enables GPs to prescribe ADHD medication for those who are stable and under the service. Post-diagnostic support is provided by our community neurodevelopmental behaviour services following assessment by community paediatrics.
3. Please outline the CYP ADHD pathway in your area, including key referral sources  
Referrals to community paediatrics for diagnostic assessment are received from our community neurodevelopmental behaviour services who provide early support, pre-diagnostic assessments, and interventions for the CYP and families/carers. Post-diagnostic support is also provided by our community neurodevelopmental behaviour services following assessment by community paediatrics as part of a multidisciplinary integrated pathway.

Nottinghamshire Healthcare NHS Foundation Trust
  - a. When did the contract(s) begin and when is the contract(s) due to end  
Contract for Neurodevelopmental Specialist Service (NeSS) started September 2020 and is reviewed on an annual basis.
  - b. What is the annual spend for this service for 2022, and for the last 5 years?  
£1.2m per year

- c. How is the service contracted – is it Block, Activity-based, or AQP contracting?  
Block
- d. If the service is commissioned with other CCGs, ICSs or Trusts, which are these?

- e. At what prevalence (% of the child population) have the contracts been commissioned against?  
The service was commissioned at the time using the following prevalence data *“ADHD is thought to affect about 2% of adults in the UK. Based on this prevalence rate, using local Mid-Year Estimates (MYE) for 2018, it is anticipated 18,380 people across Nottingham and Nottinghamshire may have ADHD. It is also estimated 3-5% of children will be diagnosed with ADHD, therefore there is an estimated 357 – 595 17-year-olds in Nottingham and Nottinghamshire that will require transition from children’s services to an adult ADHD service.”*
9. Does the same organisation as for Question 1 also deliver adult ADHD prescriptions and post-diagnosis ADHD support in your ICB area? If not, please provide the same information for this organisation.  
Yes. There is also a shared care protocol in place that enables GPs to prescribe ADHD medication for those who are stable and under the service.

Referrals are received from GPs, Prison Healthcare (for those released into the community) and CYP services as part of transition arrangements.
