Integrated Care Board (ICB) Board	The ICB Board has overall accountability for public involvement and engagement, including the Working with People and Communities Strategy. They also have responsibility for ensuring that the views of the public are appropriately considered in decision making.
Strategic Planning and Integration Committee	The Strategic Planning and Integration Committee is responsible for assuring the ICB regarding its' statutory duties for patient and public involvement.
ICB Board Committees (including Place)	There is a commitment to embed citizen voice into commissioning decisions at Place and system level through these ICB contract and commissioning committees.

	Responsibilities
Citizen Intelligence Advisory Committee (CIAG)	The CIAG will ensure that all proposals to change and improve healthcare services in Nottingham and Nottinghamshire are developed with appropriate and sufficient citizen and service user involvement and citizen intelligence and insights from patients, staff, carers and public that tell us what matters to them are taken on board and have influenced decision making.

Over the coming months, we will be:

- Recruiting a Chair for the VCSE Alliance to ensure that the experiences and views of local citizens are considered in the design and delivery of health and social care services in the region, and to enable an effective two-way flow of information.
- Continuing to hold meetings of the Engagement Practitioners Forum, bringing together engagement professionals across the Integrated Care System to share good practice around engagement and involvement opportunities and share information with other professionals around work that is happening to ensure that the patient voice is heard in all services commissioned and delivered in Nottingham and Nottinghamshire.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
