Nottinghamshire Health Informatics Service is an NHS Organisation providing all IT Support Services to the ICB via a block contract under a Partnership Agreement. The contract with Nottinghamshire Health Informatics Service renews each Financial Year.

3. Please provide manufacturer of solution(s)

Nottinghamshire Health Informatics Service provides the ICB with a Remote Access capability using Cisco AnyConnect

4. Please provide supplier of solution(s)

Nottinghamshire Health Informatics Service

5. Please provide number of licenses

Nottinghamshire Health Informatics Service provides VPN access to every ICB staff member using a corporate device..

6. Please provide average cost per user per annum

Nottinghamshire Health Informatics Service are funded through an NHS Block contract covering all aspects of support and service. Therefore it is not possible to breakdown the cost per user for this service only.
