RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do partially hold the information that you have requested. A response to your request is below.

In the request you asked:

I'd like to request the following information in e-format please:

- A list of all organisations who have a contract to provide community services to your ICB
- The annual contract value
- The end date of the contract

All contracts from the legacy organisations of NHS Nottingham and Nottingham CCG and NHS Bassetlaw CCG were transferred to NHS Nottingham and Nottinghamshire ICB on 1 July 2022. An extensive programme of work is currently underway to review the ICB's contracts register to ensure it is accurate and reflective of the newly established statutory body. .

The contracts register has been published on the website at the following link <https://notts.icb.nhs.uk/about-us/what-we-spend-and-how-we-spend-it/procurement/>. Please note the register contains the following information:

- Contract title
- Supplier name
- Contract duration
- Contract extensions
- Contract start date
- Contract expire date
- Contract description

It does not, at present, include:

- Spend (Total, Annual or contract value);

However, we do publish all ICB spend greater than 25k (including contracts) and this is published on our website at the following link <https://notts.icb.nhs.uk/about-us/what-we-spend-and-how-we-spend-it/>

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. Further details of this procedure can be obtained by contacting Lucy

If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
