**RE: Freedom of Information Request**

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to your request is below.

In the request you asked:

Can you please clarify what is your criteria for single women accessing IVF (on the NHS) within your area? Are they eligible, and if so, what are the conditions? If they need to undergo rounds of IUI first, do they need to fund that themselves privately?

I can confirm that the ICB do have a publicly available policy on IVF and other fertility health provisions, which includes eligibility criteria. You can find all the ICB policies relating to fertility on the ICB website at:

If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
