## **RE: Freedom of Information Request**

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to each part of your request is below.

In the request you asked:

Under the Freedom of Information Act 2000, I kindly request information regarding the Urgent Treatment Centre (UTC) providers operating within the Nottingham and Nottinghamshire ICS. I am interested in gathering the following details:

- 1. A list of all the UTC providers in the ICS.
  - Nottingham CityCare Partnership, London Road Urgent Treatment Centre
  - Sherwood Forest Hospitals NHS Foundation Trust Newark Urgent Treatment Centre
- 2. The dates when the contracts were awarded for each of the listed UTC providers.
  - Nottingham City Care Partnership 1<sup>st</sup> October 2022
  - Sherwood Forest Hospitals NHS Foundation Trust 1<sup>st</sup> April 2023
- 3. The dates when the contracts are due to expire for each of the listed UTC providers.
  - Nottingham City Care Partnership 30<sup>th</sup> September 2023
  - Sherwood Forest Hospitals NHS Foundation Trust 31st March 2024
- 4. Whether the contracts are expected to change in value upon renewal or if there are any planned changes to the contract terms.

Both contract values will change in line with NHS guidelines and uplifts.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and
