RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to your request is below.

In the request you asked:

I am writing to make a request under the Freedom of Information Act 2000 (FOIA) for the NHS Nottingham and Nottinghamshire ICB capital resource plan for the financial year 2023-24.

As per the Secretary of State's Directions (<https://www.gov.uk/government/publications/joint-capital-resource-use-plans-directions-to-icbs-and-nhs-trusts/secretary-of-states-directions-specifying-the-period-to-which-joint-capital-resource-use-plans-must-relate>), Integrated Care Boards (ICBs) are required to develop and publish their capital resource use plans each financial year. ICBs were requested to submit their 2023/2024 plans by March 30th.

I was unable to locate the capital resource plan for the financial year 2023-24 on your website or through other public sources. As a result, I would like to request a copy of the plan in accordance with the FOIA.

Due to extended planning timescales, NHS England advice was to delay publication beyond 30 March. 2023/24 plans have now been agreed and as such the 2023/24 Joint Capital Resource Use Plan has now been published and can be accessed via the link below on the ICS website.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
