**RE: Freedom of Information Request** 

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to your request is below.

In the request you asked:

Please could you kindly provide the following information:

- Current typical waiting time for an ASD assessment (Autism Spectrum Disorder or Condition), for a child or young person, having been referred by a GP, health visitor, or other point of referral.

(for clarity, if a child was referred on 1st January and had to wait until 30th June for their assessment appointment, this would be a wait of 180 days)

- If the areas covered by your ICB mean that there is more than one answer to the above, please provide answers for all cases.
