RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do not hold the information that you have requested. A response to your request is below.

In the request you asked:

Q1. Per calendar year between 2018 and 2022, how many people were detained under the Mental Health Act? Alongside the total, please provide a breakdown by immigration status and age.

Q2. Per month, between January 2022 to April 2023, how many people were detained under the Mental Health Act? Alongside the total, please provide a breakdown by immigration status and age.

Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
