**Dear Requestor** 

**RE: Freedom of Information Request** 

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to each part of your request is below.

In the request you asked:

- 1) The total amount that the ICB has spent on the Good Governance Institute's services since the establishment of ICBs on 1st July 2022.
  - The ICB has spent £4,885.61 with the Good Governance Institute since our establishment on 1<sup>st</sup> July 2022.
- 2) A breakdown of the specific work that the Good Governance Institute has completed for the ICB (e.g. well-led reviews).
  - The ICB has used the Good Governance Institute to support our work in developing system risk management arrangements. This included a review of draft documentation and input to a series of workshop events.
- 3) The basis on which the ICB chose the Good Governance Institute as an external facilitator for such reviews, should this be applicable.
  - In line with the ICB's Procurement Policy for spend of this value, the Good Governance Institute was chosen based on the organisation's reputation and standing.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
