
RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to each part of your request is below.

Currently there are approximately 40 pharmacists and technicians in the ICB Medicines Optimisation team who have access to GP clinical systems including SystmOne and/or EMIS Web. The Medicines Optimisation Team are fully compliant in all of the mandatory training modules outlined in the ICB Statutory and Mandatory Training Policy.
