## **RE: Freedom of Information Request**

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do not hold the information that you have requested. A response to your request is below.

In the request you asked:

1. Please confirm the number of asbestos surveys conducted at your organisation (on it's buildings) in 2018?

- 4. As per Question 1, for 2021?
- 5. As per Question 1, for 2022?
- 6. As per Question 1, for 2023 so far?

The ICB is a tenant in all buildings that are used to house ICB staff and therefore, the responsibility to undertake asbestos surveys does not lie with the ICB and we do not hold this information.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
