**RE: Freedom of Information Request** 

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to your request is below.

In the request you asked:

I am writing to you today to request information about the harmonisation of varicose veins policies workstream. Specifically, I would like to know who is responsible for aligning the CCG policies into 1 ICB policy, what their contact address and email is, and the current status of the workstream please.

Victoria McGregor-Riley, Locality Director Mid Nottinghamshire and Bassetlaw is leading the development of options for the alignment of former CCG policies into one ICB policy that relate to the treatment of varicose veins. Responsibility for the decision in respect to alignment rests with the Integrated Care Board. An options document with recommendations has been produced with clinical oversight and will go to the Nottingham & Nottinghamshire ICB Strategic Planning and Investment Committee in September 2023 for consideration.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
