## **RE: Freedom of Information Request**

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to your request is below.

In the request you asked:

I am inquiring about the commissioner at your Integrated Care Board who is responsible for cardiovascular care. Specifically, I am interested in learning more about your efforts to reduce carbon emissions, lower costs, utilise digital solutions, improve health outcomes, shorten waiting times, increase capacity, and boost participation among underserved groups in cardiovascular rehabilitation programs.

I would like to identify and potentially speak with the individual(s) who oversee cardiovascular care commissioning in your ICB. Our goal is to better understand your approach to ensuring equitable access, quality, and sustainability in CVD services. I would greatly appreciate if you could point me to the relevant commissioner(s) handling these matters.

Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
