RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we partially hold the information that you have requested. A response to each part of your request is below.

In the request you asked:

1. Has the ICB tendered a contract to replace all the GP practice websites within its territory.

No, the ICB has not tendered a contract to replace all the GP Practice websites within its territory.

2. If yes, was there a competitive tender process that was followed? If yes, how many suppliers were involved? Can you please share details?

Not applicable.

3. Has a formal award to appointment a supplier been made? Please advise the value of contract award and duration?

No, a formal award to appoint a supplier has not been made.

4. Please advise contact details of the lead commissioner and any additional stakeholders regarding the contract?

The ICB does not hold this information as there is no contract with the ICB. GP Practices are responsible for their website contracts.
