RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to your request is below.

In the request you asked:

Please can you explain the process of allocating NHS funds for NHS patients sent to Private Hospitals and Clinics for treatment, especially in terms of your ICB budget. I would be grateful if you can also tell me who is responsible (roles) for setting and managing these budgets within your ICB.

The ICB commissions services from a number of Independent Sector Providers, this allows patients to have a choice of care location and also offers our population additional healthcare capacity. These contracts are based on the needs of the population and form part of the annual planning cycle along side the provision from our NHS providers. The Independent Sector Provider contracts are based on an indicative plan that is formed from previous activity undertaken, however the contract is such that only activity undertaken is funded.

The budgets for the Independent Sector are set as part of the annual planning process and the contracts are managed by our Associate Director of Commissioning (Acute and Community Contracts).

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
