**RE: Freedom of Information Request** 

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to your request is below.

In the request you asked:

- 1. Whether the NHS Nottingham and Nottinghamshire ICB has weight management service contracts with Slimming World/Miles Bramwell or WW/Weight Watchers, either directly or through a third party organisation?
  - a. Which other weight management services does the board have contracts with?
- 2. The total amount paid over the course of any current contracts with Slimming World or estimated budget, where amount paid not available.
  - a. The total amount paid over the course of contracts with Slimming World -or estimated budget, where amount paid not available for the following financial years: 2018-2019; 2019-2020; 2020-2021; 2021-2022; 2022-2023; 2023-present.
- 3. The total amount paid over the course of any current contracts with Weight Watchers/WW or estimated budget, where amount paid not available.
  - a. The total amount paid over the course of contracts with Weight Watchers/WW or estimated budget, where amount paid not available for the following financial years: 2018-2019; 2019-2020; 2020-2021; 2021-2022; 2022-2023; 2023-present.
- 4. The start and end dates of active contracts with Slimming World.
- 5. The start and end dates of active contracts with Weight Watchers.
- 6. How many patients have accessed Slimming World through the board's partnership over the last five years, broken down by year?
- 7. How many patients have accessed Weight Watchers through the board's partnership over the last five years, broken down by year?

Nottingham and Nottinghamshire ICB do not hold any contracts with Slimming World/Miles Bramwell or WW/Weight Watchers and therefore do not hold this information.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make
