RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to each part of your request is below. In the request you asked:

- The ICB's total spend on IVF for the financial year 2022/23, broken down by cycle The ICB's total spend on IVF for the financial year 2022/23 was £480,800. Please note that this total is for patients with a postcode from the legacy Nottingham and Nottinghamshire CCG area and relates to the first cycle of IVF as Nottingham and Nottinghamshire only commission one cycle. We do not hold the information for patients with a postcode from the legacy Bassetlaw CCG
- 2) If tenders for IVF cycle contracts are set at a fixed price or are open to bidding, or both?
 - How many were bids?
 Not applicable.
 - How many were fixed cost?
 The ICB tendered for these services on a fixed price basis. There was a single tender process.
- 3) The total number of cycles of IVF the ICB funded for the year 2022/23
 - The total number of cycles of IVF the ICB funded for patients with a postcode from the legacy Nottingham and Nottinghamshire CCG area for the year 2022/23 is 422. The ICB does not hold the information for the number of cycles of IVF funded for patients with a postcode from the legacy Bassetlaw CCG area.
- 4) The total number of people who received NHS-funded IVF in the ICB's footprint for the year 2022/23

The total number of people who received NHS-funded IVF for patients with a postcode from the legacy Nottingham and Nottinghamshire CCG area for the year 2022/23 is 240. The ICB does not hold the information for the number of people who received NHS funded IVF for patients with a postcode from the legacy Bassetlaw CCG.

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have.
