With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to your request is below.

Does NHS Nottingham and Nottinghamshire ICB have any local treatment guidelines, pathways or protocols for the use	Yes/No
of human growth hormone?	If Yes, please provide a copy.

For patients with a postcode from the legacy Nottingham and Nottinghamshire CCG area, there are no Nottinghamshire Area Prescribing Committee (APC) guidelines for the use of growth hormone (Somatropin) in interstitial lung disease or idiopathic pulmonary fibrosis. There is shared care guidance for other indications.

All APC guidelines are publicly available on the APC website (<a href="https://www.nottsapc.nhs.uk/">https://www.nottsapc.nhs.uk/</a>) and can be accessed via the Joint Formulary (<a href="https://www.nottinghamshireformulary.nhs.uk/">https://www.nottinghamshireformulary.nhs.uk/</a>).

For patients with a postcode from the legacy Bassetlaw CCG area, there are two shared care guidelines for Somatropin, one for children and one for adults. The one for children also includes Somatogron.
