RE: Freedom of Information Request

With reference to your request for information I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information that you have requested. A response to your request is below.

In the request you asked:

Please can you let me know where I can find information about the proportion of your budget that has been spent on buying up mental health capacity in the private sector (both in-patient services, and community services)?

I'm aware that tendered contract information is available on the gov.uk website, but would like additional information (for example bed capacity which is being bought from private hospitals).

The ICB spend on private healthcare sector capacity for mental health is as follows.

2023/24 forecast

- Private provider locked rehabilitation mental health - £2.934m
- Non Contracted activity private provision for mental health - £150k
- Talking Therapies spend with private provider - £20.310m

Total: £23.394m

If you are unhappy with the way in which your request has been handled, NHS Nottingham and Nottinghamshire Integrated Care Board (ICB) have an internal review procedure through which you can raise any concerns you might have. If you remain dissatisfied with the outcome of the internal review, you can apply to the Information Commissioner's Office (ICO), who will consider whether the organisation has complied with its obligations under the Act and can require the organisation to remedy any problems. Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by NHS Nottingham and Nottinghamshire ICB.
